1. CFS 43 plenary and side events report (Matthew Cousins)

Overview of the nutrition events that took place during CFS 43 on 17th to 21st October 2016:

- Whilst nutrition was more visible than before the Rome Declaration, it has yet to be properly embedded as a cross-cutting outcome of better food security, but many more nutrition took place
- SDGs were central to discussions: transformative agendas, interconnectedness, breaking out of silos, the role in achieving SDGs of food security (and agriculture), resilience, climate and the environment (agro-ecology), and reference to water, land use and tenure, engagement of youth
- On common and differentiated approaches, context is clearly key. Concerns were raised on monitoring hunger and food security and that “countries are rushing into implementation” without agreed international standards for a global indicator framework, that national frameworks need to be disaggregated, and subnational, to capture inequalities, which is especially important if the principle of leaving no-one behind, and reaching the hardest to reach
- Some of the strongest exchanges, in the plenary, were around human rights

- The multi-stakeholder approach was well ingrained, although the Civil Society Mechanism pointed out the ability to engage in dialogue is often dependent upon resources
- CSM and PSM were very well organised, deploying voices from around the world. PSM in particular, with interventions from small, medium and large companies, and language often similar to that used by the CSM. The World Farmers Organisation, as a new dynamic, reinforced the production aspect of food security, with nutrition seen as an outcome of improved (cattle) yields (meat and milk as animal-source protein)
- A number of Member States, and others, highlighted the need to better communicate the work of the CFS, making decisions on policy convergence and 'products' more accessible. The focus often being on getting visibility in New York (HLPF, 2030 Agenda)

2. Debrief on Gerda's country visit to Ghana (Ferran Perez)

Follow up actions:

- Important for networks to reach out to respective constituencies in Ghana to discuss if they meeting and engaging, or trigger them to meet, to follow-up on the visit
- Gerda to engage Lead Group after December elections to scale-up multi-sectoral engagement
- It is important for networks to have a mission report so they can follow up with country offices.

3. Update on the Strengthening the SUN Support System workshop preparation (Sergio, All)

- Clarification given on BRAIN, and email from Fanny Granchamp with background documents and questions. Objective is to get a picture of how networks are currently operating, so the Secretariat can decide if and when to migrate to a new platform, and what that platform should look like
- It would be ideal for all networks to use BRAIN to organise country requests for assistance, and the status of the responses, creating a platform where all can access requests and track responses
- It is important to know how each network currently manages and tracks requests, the type and volume of requests received, appreciating that every network operates differently.
- Fanny will have bilateral calls with each of the network facilitators to go through the questions
- At the November workshop we will analyze the platform and decide on a way forward, including the role of the Networks as services providers in addition to MQSUN, and others
- Service providers will participate in the workshop and present the services they offer

Col and Network Accountability:

- Breda is preparing a discussion on how Conflict of Interest should advance in the coming years, and will debrief on a consultation with the Col working group in a parallel session at the workshop
- A presentation at the November workshop will elaborate on Network Accountability
- Country network updates to be included in the first half of day 2: deliverables and lessons learned

Update on Analytical exercise:

- UN Network is working on unpacking the data and looking at SUN process markers, additional variables and progress against WHA targets as well as presence of Networks on the ground. This will enable us to match those analyses with perceived needs against demands expressed by countries.
- A first draft should be circulated by 04 November for comments.

UN Network

- UN Network will have its face to face meeting in Rome with the Steering Committee on November 9th. Agenda includes: finalization and dissemination of the UNN SUN Strategy and CAN, resource mobilization, TA provision, communications. TA will be relevant to upcoming workshop.
- Reach Facilitators annual meeting will be 28-30 November in Rome, before FAO/WHO International Symposium on Food Systems-healthy diets.
- UNN preparing for first annual reporting exercise: developing and piloting data tools, and an on-line dashboard. Pilot country start by 11-11, and should report at upcoming workshop.

5. AOB

CoP22- (Matthew Cousins)

- In May 2016 United Nations Secretary-General Ban Ki-moon appointed Mrs. Mary Robinson, SUN Lead Group member, and Ambassador Macharia Kamau of Kenya as his Special Envoys on El Niño and Climate. The Envoys have been tasked with calling attention to the severe global human security impact of the El Niño, supporting the mobilization of resources required to address the immediate needs, and mobilizing an integrated response to prepare for future needs related to the impact of climate change on weather conditions.
- The Special Envoys proposed a 'Blueprint for Action' aiming to catalyse and guide the development of robust multi-stakeholder actions to build resilience in vulnerable countries.
- The Blueprint will be discussed further at a multi-stakeholder roundtable consultation at COP22 in Marrakesh, Morocco on November 14th 2016. SUN has been asked to identify members of SUN Network, individuals or organization interested in attending the event, and to insert nutrition in the agenda as a recognized maker and marker of resilience. Having Nutrition in the blueprint will make it easier for Focal Points to make sure their nutrition plans integrated.
- After the meeting there will be wider consultations on the blue print for action.
