1. Context: Extension of the SUN Pooled Fund 2.0

The Scaling Up Nutrition (SUN) Movement Pooled Fund 2.0¹ was launched in 2017 to provide catalytic funding support for SUN Countries in their efforts to end malnutrition in all its forms. The SUN Pooled Fund 2.0 took a collective, multi-stakeholder and multisectoral approach and contributed to the implementation of the SUN Movement Strategy and Roadmap 2016–2020 and the development of the SUN 3.0 strategy.

All grants awarded under Pooled Fund 2.0 were planned to close by December 2021. On 23 July 2021, the Consultative Group of the SUN Pooled Fund 2.0 agreed on a proposal to keep the Pooled Fund operational until 30 June 2022 in order to implement a set of activities to support SUN Countries and ensure a timely closure of operational and administrative processes. The SUN Movement Executive Committee endorsed this proposal on 30 August 2021. Building on the 2022 SMS workplan and budget,² the Consultative Group approved on 31 July 2022 an additional, final, timebound, no-cost extension for the remainder of 2022.

The objectives of the work during the extension period from January to December 2022 included:

- → Ensuring the proper operational closure of the grants being implemented over the period 2018 to 2021, including documenting the final results of these grants (reflected in the Pooled Fund 2.0 Final Report³ and on the website⁴).
- → Allocating the remaining balance for technical assistance to SUN Countries and grant support to Civil Society Network (CSN) country activities.⁵
- → Conducting a review of the achieved impact of the SUN Pooled Fund 2.0 as well as lessons learned (reflected in the SUN Pooled Fund Review).⁶

2. 2022 activities and outputs

For the final phase of the extension period, 1 July–31 December 2022, unspent funds from the previous grant cycle were allocated to support a \$100,000 grant to the CSN and a \$200,000 contract to Development Initiatives (DI) in support of SUN Country requests.⁷ With a focus on strengthening the engagement of national-level Civil Society Associations, the CSN grant supported the development phase of a planned three-year Global Fundraising Training Programme and the delivery of an International Institute for Infrastructure Resilience and Reconstruction (IIIRR)⁸ nutrition-sensitive programming training to 10 participants from nine countries. With a focus on responding to priority technical assistance requests from SUN Countries, the DI contract provided technical assistance support, including workshops, analyses and reports for nine countries (Burkina Faso, Burundi, Costa Rica, Guatemala, Guinea-Bissau, Honduras, Mali, Sudan and Uganda), details of which are found below.

2.1. Capacity strengthening for Civil Society Networks

Out of its grant funding, the CSN budgeted \$70,000 for the development of a 12week, online, certificated fundraising foundations course. Available in English, French and Spanish and open to all of the 4,000-plus SUN Civil Society Alliance (CSA) members and national SUN CSAs, the course was designed to provide participants with practical information on developing and implementing a fundraising strategy. Building on a fundraising course that was piloted in 2021, this course also incorporated a community engagement platform to maintain contact among learners and provide future opportunities for mentoring and support. At the close of this support period, in December 2022, this leadership course won an award from the Reimagining Fundraising Global Innovation Challenge, unlocking an additional £65,000 in 2023– 24, which will be invested in improving and expanding access to the course.

The rest of the grant funds to the CSN, totalling \$30,000, were budgeted to support the delivery of an IIIRR nutrition-sensitive programming training. From among more than 110 applications, 10 participants from nine countries were selected to attend the two virtual sessions and one week-long, in-person session in the Philippines. Thanks to funding from other sources, an additional seven CSN participants were able to join, and the cohort worked together on action plans to translate their learnings into activities for their home countries.

2.2. Technical assistance and capacity strengthening for SUN Countries

Funding through the contract with DI supported a prioritized set of technical assistance interventions in nine countries. The selection of interventions from among the total requested by countries was based on a prioritization review with all networks across the SUN Global Support System (GSS) and involved collaboration with other funded technical assistance mechanisms, where relevant.

- → Burkina Faso: Budget analysis capacity-strengthening workshop
- → Follow-up budget analysis exercises supported by UNICEF
- → Burundi: Budget analysis capacity-strengthening workshop
- \rightarrow Costa Rica: Budget analysis capacity-strengthening workshop
- → Guatemala: Monitoring and evaluation support for implementation of the National Food and Nutrition Security Policy
- → Guinea-Bissau: Budget analysis capacity-strengthening workshop
- \rightarrow Collaboration with independent consultant, supported by other funds
- → Honduras: Budget analysis capacity-strengthening workshop
- → Mali: Monitoring and evaluation workshop and technical recommendations report
- → Sudan: Costing readiness exercise for the national nutrition plan
- → Uganda: Consultations and strategy support to establish a SUN Business Network

Work products also were planned for El Salvador and Tajikistan, but these were not able to be delivered during the grant extension period. These country requests are being redesigned for 2023 and will be taken up by the GSS at that time.

3. Review of the Pooled Fund 2.0

A comprehensive evaluation and consultation⁹ exercise resulted in the Pooled Fund 2.0 Review Report,¹⁰ which was finalized and shared in February 2022, with final edits on 8 March 2022. The report provides an overview of the SUN Pooled Fund 2.0 window/cycle periods and focus areas, implementation period, average grant amounts/number of awards and total funding provided for the period 2018–2021 (see Table 1).

In summary, the following key recommendations and observations were highlighted:

Recommendation 1:¹¹ Continue funding the SUN Pooled Fund to support catalytic country-led actions for the multisectoral national nutrition response. Proposed grant duration: Increase to three years.

Recommendation 2:¹² Support four SUN Pooled Fund grant windows. Separate funding cycles for appropriate evaluation design, criteria and overall grants management:

- → Government-led Multistakeholder Platform (MSP) coordination and governance support
- → CSAs
- → SBNs
- → Fragile and conflict-affected situations

Plus:

- → Incentivize the development of joint proposals emanating from two or more incountry networks (or government-led MSPs) and, ideally, build on joint strategies. It should also be considered to leverage the annual Joint Annual Assessments as a means to discuss opportunities and collective ideas.
- → Cross-cutting grant criteria and success factors, to include gender equality, youth engagement, private-sector engagement, capacity development, mutual accountability, climate and environment, and alignment with country priorities and context.

Recommendation 3:¹³ Support targeted technical assistance focused on resource mobilization. This includes support to SUN Countries by strengthening institutional capacities for additional resources for nutrition (public/private, blended financing) and to fill knowledge gaps on nutrition financing.

Recommendation 4:¹⁴ Designate up to 30 per cent of all grants for fragile and conflictaffected situations.

Recommendation 5:¹⁵ Strengthen learning and knowledge-sharing from grantees. This includes the sharing of lessons learned, best practices and challenges among SUN stakeholders (grantees and non-grantees) through a coordinated strategy.

Recommendation 6:¹⁶ Regionalize grants management and streamline processes. Main focuses are to decentralize grant evaluation using regional and SUN Country Network platforms and to streamline and simplify results-based reporting and monitoring in line with SUN 3.0.

4. Closure of the Pooled Fund

This section documents the administrative closure process, including the extension activities in 2022¹⁷ to be completed in 2023.

Following the start of the operational closure of the SUN Pooled Fund 2.0 grants by 31 December 2021, the Pooled Fund 2.0 Final Report¹⁸ was published and circulated in March 2022. Previous reports and all relevant information on past grants and activities are available on the SUN website.¹⁹

In light of the extension of the SUN Pooled Fund 2.0 to 31 December 2022, the operational and financial closures also were extended and are expected to be completed by end of the third quarter of 2023.

After extensive consultations with donors, there was a clear consensus to not develop a third iteration of the SUN Pooled Fund. Therefore, the closure in 2023 will be the final step in this process. Donors did, however, express an interest in supporting capacity strengthening interventions and improving the functionality of MSPs for nutrition at the country level. The experiences of implementing the SUN Pooled Fund 2.0 will inform these future streams of work and the design of any new funding mechanisms to support them.

^{1.} The total budget approved by the Consultative Group in July 2022 was \$488,669. There was a formula and calculation error, and the exact amount of the budget should be \$487,969.

^{2.} The approved budget (July 2022) of \$487,969 is slightly higher than the June 2022 budget balance of \$486,796. This is because the July 2022 budget was presented to and approved by the Consultative Group against a higher projected balance of \$488,761. However, the total expenditures of \$470,131 are within the total budget available.
