# PROGRESS TOWARDS SUN 3.0 STRATEGIC OBJECTIVES (SO)

- → SO.1 Strengthen and sustain strong policy and advocacy environments

  Continuation of the anchoring of SUN at the level of the Prime Minister's

  Office; revitalisation of the government platform through advocacy
  activities for the commitment of all Secretaries General of all ministries,
  and the identification of focal points in each ministry; establishment of
  the National Nutrition Council; establishment of the Permanent Bureau of
  the National Nutrition Council (BPCNN), acting as the board of directors
  of the National Nutrition Office (ONN).
- → SO.2 Develop and align shared country priorities for action
  Establishment of the National Nutrition Policy (2022-2030);
  establishment of the National Multisectoral Action Plan for Nutrition
  (2022-2026); establishment of the National Monitoring-Evaluation,
  Accountability and Learning Plan for Nutrition; establishment and official
  launch of the Roadmap of the Social Safety Nets project during the
  national conference on food self-sufficiency, organised from 16 to 18
  June 2022 under the chairmanship of His Excellency the President of the
  Republic of Madagascar.
