

SUN Movement contributions to the N4G Summit 2025 Additional Report

May 2024 - March 2025

Executive Summary

This report outlines the SUN Movement's contributions to the Nutrition for Growth (N4G) Summit 2025 in Paris, spanning from May 2024 to March 2025. The SUN Movement played a pivotal role in support to the N4G host, the French Ministry of Europe and Foreign Affairs, by co-chairing the International Advisory Group (IAG) and through the active participation of the SUN Secretariat and SUN networks in the mobilization of commitments and preparation of the Summit plenary sessions and roundtables as well as through different side events.

Key Contributions and Deliverables:

- Leadership Role: The SUN Movement Coordinator co-chaired the IAG, contributing to the Summit's overall design and strategic direction.
- **Reference Documents:** The Movement contributed to the development of key N4G reference documents and guidance leveraging on its previous substantial work to prepare the SUN Global Gathering on similar thematics, ensuring they reflected a country perspective and incorporated lessons learned from previous Summits.
- Global Mobilization: SUN actively participated in mobilization efforts, engaging with diverse stakeholders and tracking developing commitments in the making, to point out the gaps and secure further in-country support where it was most needed.
- **Country Engagement:** The SUN Movement Secretariat supported the 67 SUN countries and with more individual support through different technical assistance providers 50 SUN countries across five regions in preparing and submitting their N4G commitments.
- Global Nutrition Integration Compact: The Movement supported the dissemination and launch of the Global Nutrition Integration Compact, with 39 countries expressing interest to the SUN Movement Coordinator to date.
- **Civil Society Contributions:** The SUN Civil Society Network played a significant role in mobilising nutrition commitments and strong civil society participation in the lead up to and at the Summit, through the organisation of local and national

civil society dialogues, the civil society pavilion, solutions village, side events, a civil society declaration, amplifying civil society voices and priorities .

- Youth engagement: The SUN Civil Society Network, alongside other partners, positioned young people prominently by demonstrating the outcomes of hundreds of youth-led nutrition dialogues around the world at the society pavilion, solutions village, side events, press conference, media interviews, high-level bilateral meetings, as well as in the opening and closing of the Summit during which they issued a powerful call to action. This meaningful youth engagement has been valued by high-level stakeholders and there is active follow-up to ensure their words turn into action at upcoming moments (CFS53, UNFSS+4, COP30, etc.)
- Summit Participation: The SUN Movement actively participated in the N4G Summit, with 61 out of 76 low- and middle-income country delegations belonging to the Movement, and 33 SUN Focal Points present at the Summit and actively engaging in various sessions. 100% of the plenary sessions featured at least one speaker representing a SUN country.

Key Outcomes:

- N4G Commitments: 55 non-donor governments made commitments, with 48 (87%) being members of the SUN Movement. 66% of the SUN countries' commitments are related to integrating nutrition in another sector. By the time of the Summit, 18 national-level SUN Civil Society Alliances had already registered their commitments in the Nutrition Accountability Framework (NAF), with at least a dozen more to follow suit by end June.
- Final Declaration: The Summit's final declaration recognized the IAG's work, cochaired by Côte d'Ivoire and the SUN Movement, and stated that a coalition of partners, working with the SUN Movement, will ensure coherence and sustained momentum between N4G Summits.

In summary, the SUN Movement provided significant support to the French Ministry of Europe and Foreign Affairs in delivering a successful N4G 2025 Summit, by contributing to the shaping of the N4G governance and processes, facilitating country-level engagement, shaping critical documents, preparing the Summit sessions and supporting mechanisms enabling follow-up and accountability after the Summit.

I. Preamble

Following the postponement of the SUN Movement Global Gathering (GG), initially scheduled for October 2024, the SUN Movement Secretariat (SMS) redirected its activities and resources towards preparations for the Nutrition for Growth (N4G) Summit 2025 in Paris. The SUN Movement was assigned a leading role within the N4G Summit's

governance structure. The SUN Movement Coordinator (United Nations Assistant Secretary-General), who leads the Movement, served as co-chair of the International Advisory Group (IAG). Concurrently, 20 SMS staff members from various teams— primarily the Country Action Team (including its Regional Hubs), Communications, Partnerships and Financing, and Operations—directed their efforts towards the Summit. This work involved facilitating global processes and providing support for country-level planning across the majority of the 67 SUN Movement member countries. The secretariats of the SUN networks also contributed significant efforts to engage their members and support the organization of N4G Paris. This report summarizes these different contributions.

II. SUN Movement's Role in the N4G International Advisory Group (IAG)

The Government of France established an N4G governance structure comprising a national steering committee and an International Advisory Group (IAG). The SUN Movement Coordinator received the mandate to Co-Chair the IAG, serving alongside the Côte d'Ivoire SUN Government Focal Point. The IAG consisted of 69 nutrition stakeholders from governments, international organizations (including UN-Nutrition), civil society (including the SUN CSN), philanthropy, and the business sector (including the SUN SBN). Its primary task was to provide strategic advice pertinent to the Summit's organization and to support the mobilization of commitments for nutrition-sensitive policies and investments. The ASG and the SUN Movement Secretariat contributed to the definition of the Terms of Reference of the IAG and the recruitment of a coordinator for itsAdministrative Independent Support Unit (AISU), which received support from UNICEF and Nutrition International. The IAG was formally launched in September 2024.

In the capacity of IAG Co-Chair, the SUN Movement Coordinator contributed to shaping the N4G process and the overall design of the Summit, supporting the French organizers led by N4G Special Envoy Brieuc Pont. The SUN Movement Coordinator co-chaired and participated in five IAG plenary meetings hosted by the SUN Movement Secretariat. Each meeting convened approximately 150 participants, functioning as regular platforms to update the international community on the progress of Summit preparations.

Development of N4G Paris Reference Documents

The IAG contributed to the development of key reference documents for the N4G Paris Summit through dedicated multi-constituency working groups co-led by various UN agencies.

- Technical Working Groups: Two groups reviewed and provided recommendations on the primary reference documents: the "Vision and Roadmap" and the "Commitment Guide" (including principles of engagement). UN-Nutrition, under the leadership of the UN-Nutrition Chair, convened the working group to review and advise on the Commitment Guide.
- Thematic Working Groups: Six groups developed commitment recommendations aligned with the N4G Paris themes, as defined in the "Vision and Roadmap".

As IAG Co-Chair, the SUN Movement Coordinator worked in tandem with Côte d'Ivoire, overseeing the work conducted by these technical and thematic groups. This involved reviewing their deliverables prior to submission to the French Ministry of Europe and Foreign Affairs (MEAE), accompanied by recommendations formulated by the IAG co-chairs. Both Co-Chairs made sure all documents were elaborated with a country perspective.

Staff from the SMS, UN-Nutrition, SUN Civil Society Network (CSN) and the SUN Business Network (SBN) participated across all N4G technical and thematic working groups, bringing forth experience derived from country-level policy initiatives and incorporating lessons learned from the 2021 N4G Summit in Tokyo. As the N4G thematic groups addressed subject matter similar to that planned for the SUN GG, the SUN Movement was able to offer the significant foundations prepared for the GG in the areas of climate and food systems transformations, health and social protection, financing for nutrition, research, innovation, data and resilience to the benefit of the N4G working groups. Furthermore, the SUN Movement Secretariat undertook the translation of all core N4G documents—including the Vision, Engagement Guide, six Thematic Guides, and the summary—from English into both French and Spanish, ensuring broader accessibility across SUN countries.

Mobilization of the Global Community

An "inter-working group," established as a sub-group of the IAG in December 2024, was dedicated to coordinating mobilization efforts among diverse stakeholders. SUN Movement through SMS, CSN and UN-Nutrition contributed to this group, which convened weekly. During these meetings, SMS shared information from its country support activities (detailed in Section VII) and provided intelligence regarding developing commitments, tracked through the SUN Global Support System efforts.

In addition, SUN participated in the "N4G outreach group," a collective comprising the

GNR, civil society members, UN agency representatives, the SUN Movement Secretariat, UN-Nutrition, and CSN. This group concentrated its efforts on mobilizing Low- and Middle-Income Countries (LMICs), with a particular focus on nations not currently part of the SUN Movement. They developed a commitment tracker, modeled on SUN's existing N4G tracker, to monitor progress. Within this forum, SUN SMS provided weekly country updates and highlighted technical assistance (TA) gaps within SUN countries for consideration by other partners. SUN SMS, CSN, and from the UN-Nutrition Secretariat also contributed to two global webinars organized by members of the outreach group and hosted by the SUN CSN. The SUN Movement Secretariat regularly communicated with its country focal points and the GNR to ensure that prepared commitments were properly and timely submitted in the NAF.

Preparation of the Summit's Sessions

The IAG held the responsibility for developing and organizing the six plenary sessions, each dedicated to a specific theme, along with four round tables for the Summit. Co-leads of the thematic working groups and other pertinent IAG members undertook the development of concept notes and the identification of speakers. SUN SMS co-led the design and organization of a round table focused on the intersection of gender, health, and nutrition, and contributed to shaping the framework for all four roundtables.

Throughout the session planning process, the SUN Movement Coordinator provided structure and guidance to ensure relevance and coherence. Her role involved reviewing draft concept notes and engaging with session organizers, offering recommendations concerning session content and the suitability of proposed speaking roles. IAG Co Chair SUN FP from Côte d'Ivoire ensured a strong country perspective all throughout.

Furthermore, the SMS supported the task of mapping and distributing speakers across the various sessions. This process entailed profiling country experiences relevant to different session themes and mapping specific country examples to promote balanced geographical representation and visibility. These efforts were conducted in close coordination with the AISU and the French organizers.

Communication Strategy Support

The SMS contributed to the N4G Communication Strategy through several activities. These included facilitating media engagement, which resulted in interviews by IAG chairs appearing in various news outlets. The SMS was also involved in content production, designing and supplying materials for official N4G campaigns. Amplification efforts involved producing and distributing social media content through SUN channels, utilizing N4G-specific messaging and tags. A contribution was the development of a dedicated N4G page on the SUN website, which was used by SUN countries. The creation of five success stories, featuring <u>El Salvador</u>, <u>Sri Lanka</u>, <u>Côte d'Ivoire</u>, <u>South Sudan</u>, and <u>Zambia</u>, showcased practices and nutrition outcomes, generating over 2.2 million video views and reaching an audience of 1.3 million people. Finally, the development of structured message grids aimed to ensure consistent communication throughout the campaign.

III. Supporting SUN Country Engagement

At both regional and country levels, the SUN Movement Secretariat, with the backing of technical assistance partners funded by the European Commission (EC), provided support to SUN countries in preparing their engagement for the N4G Summit. This support involved socializing the N4G Paris guidance to aid countries in developing SMART commitments aligned with national, regional, and international priorities. Efforts were also made to encourage cross-sector collaboration and promote the integration of nutrition actions across various sectors.

This regional socialization process was facilitated through a series of webinars and inperson workshops conducted across different regions. As part of these efforts, the SMS hubs and CSN regional advisers co-organized:

- 4 in-person regional workshops:
 - June 2024 (Francophone Africa): Workshop for 7 SUN Countries on reviewing past N4G commitments, organized by the SUN Dakar Hub concurrently with the Francophone Africa CSN Regional workshop, attended by the N4G Special Envoy and SUN Coordinator. The CSN workshop had 50 participants from 23 CSAs. Subsequently, 16 country-level workshops were held to formulate commitments, supported by TA brokered by the SUN Dakar Hub.
 - September 2024 (Latin America & Caribbean LAC): Workshop in Panama City hosted by the SUN SMS LAC Hub for 14 focal points from 8 SUN countries, attended by the N4G Special Envoy and organized with EU4SUN, FAO Mesoamerica, and supported by Brazilian and Mexican Cooperation. The workshop focused on sharing practices for formulating and operationalizing commitments.

- Dec 2024 & Feb 2025 (Anglophone Africa & Convergence Hubs): Two workshops attended by over 100 stakeholders from 16 Anglophone Africa SUN Countries and 6 Convergence Hub Countries organized with C4N, FIIAPP, GNR, and the French Government to orient participants on the commitment guide and expedite roadmap development.
- 2 webinars:
 - Nov 2024 & Jan 2025 (Anglophone Africa & Asia): Two webinars for the SMS Anglophone Africa and Asia hubs to raise awareness about N4G processes, involving GNR, N4G working groups, C4N, EU4SUN, and the SUN Global Support System. Over 120 Multi-Stakeholder Platform (MSP) members from 27 SUN Countries attended.

• 6 Communities of Practice webinars:

- Oct 2024 Mar 2025 (LAC Hub): Six webinars as part of the EU4SUN project, covering N4G priority topics and guidance attended monthly by Focal Points and networks from 8 LAC countries and Haiti.
- 1 regional media N4G online workshop:
 - Jan 2025 (West/Central Africa Media): Regional online workshop for media partners on N4G and media advocacy, organized by the Dakar SMS Hub with the SUN Regional Network of Journalists (IJ-CAN) and EU4SUN support. 70 participants from 18 SUN countries attended.

Regarding technical assistance (TA), 50 SUN Countries across the five regional hubs received support to assess their 2021 N4G commitments and/or formulate new commitments for 2025. This TA was delivered by partners including EU4SUN, C4N, FCDP, Nutrition International, CARE, GAIN, Save the Children, ACF, GIZ, the World Bank, UNICEF, FAO, and WFP. The SUN SMS Regional Hubs encouraged countries to utilize their Multi-Stakeholder Platforms (MSPs) for inclusive commitment-making processes, ensuring sub-national involvement.

Through Irish Aid funding, the UN-Nutrition project "strengthening one UN through UN-Nutrition country support" enabled the Secretariat to tightly follow up N4G commitment implementation and making at national level in a limited number of countries where UN-Nutrition agreed on a joint work plan in support to nutrition governance and nutrition stakeholders coordination, in link with other global initiatives (e.g. food systems summit) towards achievement of Sustainable Development Goals and nutrition targets. In every supported country the UN-Nutrition project was directly supporting the SUN multi sectoral platform on N4G and other issues.

The SUN SMS Regional Hubs provided continuous daily support through various means. This included coordinating with in-country TA consultants, offering strategic guidance on commitment review methodologies, assisting with the coordination of inclusive commitment-making processes, and recommending tools and approaches in collaboration with TA providers. SMS also liaised with the Global Nutrition Report (GNR) to assist countries facing technical challenges with commitment registration in the Nutrition Accountability Framework (NAF), advocated for SMART commitments at regional events, and supported partner initiatives aimed at engaging more relevant actors at the country level.

As the Summit date neared, the SUN SMS Regional Hubs also played a role in expediting the formation of country delegations. They worked to secure funding for the participation of several SUN Government Focal Points through EC-funded TA providers and other partners like HKI. Additionally, they supported SUN Government Focal Points in coordinating with Ministries of Foreign Affairs to facilitate the official designation of delegations and manage visa processes for attendees.

The SUN Movement Coordinator engaged in high-level mobilization efforts in the period leading up to the N4G Summit. These efforts included accompanying the N4G Special Envoy on visits to Madagascar and the Finance in Common Summit in South Africa. The visit to Madagascar, organized by the SUN Dakar Hub, aimed to strengthen the nation's commitment to nutrition through high-level political engagement. This visit involved assessing ongoing nutrition initiatives and validating the country's national N4G commitments during a workshop, thereby ensuring alignment with national priorities and securing stakeholder support. Outcomes from this mission included the reinforcement of stakeholder collaboration, the identification of needs such as increased domestic funding for nutrition, and the development of a specific national commitment linking nutrition interventions with climate change adaptation strategies. The mission concluded by establishing follow-up actions designed to maintain momentum for implementing nutrition strategies.

IV. The Global Nutrition Integration Compact and Coalition

The SMS, with contributions from the Director and the Country Action team, supported the Global Compact for Nutrition Integration, an initiative initiated by the Foreign, Commonwealth and Development Office of the United Kingdom. This support was manifested through the dissemination of the Compact to SUN Focal Points via regional consultations and meetings conducted across all five hubs during February and March 2025. These initial disseminations were followed up with bilateral exchanges with numerous SUN countries to promote understanding and engagement.

As a consequence of these efforts, 39 countries, including the donor country Ireland, signaled their interest in the Compact through the dedicated SUN webpage. This group was joined by 6 SUN civil society alliances and 2 in-country SUN youth networks. Furthermore, 11 organizations, including HKI, Save the Children UK, World Vision International, GNR, Path, Mercy Corps, and 4SD, expressed their interest directly to the SUN Coordinator via the same webpage mechanism. UN Nutrition also signaled their interest in the Compact to FCDO.

The SMS actively participated in the launch of the Nutrition Integration Compact and Coalition, which took place during a side event hosted at the British Ambassador's Residence. This event convened representatives from SUN Networks and several SUN countries, including the Philippines whose representative served as a speaker, alongside numerous global stakeholders and partner organizations such as the Green Climate Fund, AfDB, GFF, World Vision, FCDO, the African Union, and ATNI. The event featured an intervention from the SUN Coordinator and the SUN CSN presented the achievements of various Civil Society Alliances in advancing nutrition integration. A <u>virtual poetry performance</u> by SUN CSN Youth Coordinator Vanessa Chisakula was also featured.

Complementing the launch event, a dedicated side event focusing on the Nutrition Integration Coalition was organized within the main conference venue, featuring an intervention by the SMS Director. The Coalition was presented during this session as a bridging mechanism intended to ensure continuity and collaboration between successive N4G Summits, and as a platform through which the influence and experience of SUN countries could be harnessed.

V. SUN Civil Society Contributions

In alignment with the vision articulated by the French organizers, civil society, and particularly the SUN Civil Society Network (CSN), played a role in the preparations for the N4G Paris Summit. Beyond its participation in various N4G technical and thematic groups, as well as the N4G Outreach group, the CSN, in collaboration with 4SD and World Vision International (WVI), provided support for 346 nutrition dialogues conducted across 54 countries. These dialogues engaged over 10,000 participants and generated key findings

that were subsequently made publicly available, contributing to the overall mobilization efforts towards the Summit.

Civil society organizations collectively organized the Civil Society Organizations (CSO) Pavilion, a two-day side event held immediately prior to the official Summit, which attracted approximately 400 participants each day. Within this pavilion, the SUN CSN cohosted six distinct side events focusing on themes including civic space, gender equality, youth leadership, financing mechanisms, and accountability frameworks. Notable events included:

- A gender-focused side event at the Pavilion, employing a participatory world café format to showcase gender-transformative programming from SUN CSAs in Vietnam and Sierra Leone, advocating for increased investments in genderresponsive approaches.
- An afternoon session and reception dedicated to **accountability**, co-led with ACF and the Civil Society Accountability Task Force, issuing calls for transparent and funded monitoring plans for N4G commitments, renewed parliamentarian engagement, and mid-point accountability events between Summits.
- A youth-centered side event, "Stronger Together: Powering Youth-led Dialogues at the Grassroots Level," co-hosted by SUN CSN and SMS, showcasing the Youth Leader for Nutrition programme's impact and multi-stakeholder collaboration.

At the **Village of Solutions for Nutrition**, the SUN CSN maintained a presence with four thematic and technical stands showcasing the impact of Civil Society Alliances and youth coordinators on:

- 1. Promoting financial transparency and accountability in nutrition.
- 2. Valuing the voices and knowledge of local communities.
- 3. Strengthening gender equality to improve nutrition outcomes.
- 4. Empowering communities in the transition towards sustainable and equitable food systems.

The youth-led exhibition stand attracted interest, including visits from King Letsie III of Lesotho, the First Lady of Brazil, WFP Executive Director Cindy McCain, David Nabarro, UK Members of Parliament, and representatives from various donor agencies. The impact

of the Nutrition Dialogues was further emphasized during a side event within the Solutions Village, co-organized by the SUN CSN and featuring speakers such as David Nabarro, representatives from Irish Aid, the SUN Focal Point from the Philippines, and two SUN CSN Youth Coordinators (Nigeria, Philippines). This event resulted in commitments from panelists to continue supporting the SUN CSN in enabling youth leadership through this community dialogue model.

VI. SUN Movement at the Paris N4G Summit

The SUN Movement Coordinator, accompanied by a delegation comprising 7 SMS staff members including the Director, team leads, regional representatives, Lead group and ExCom members. The SUN Civil Society, Business, Donors and United Nations networks were well represented, including seven SUN CSN Secretariat staff, 16 SUN CSN youth coordinators, the UN-Nutrition Chair and Senior Coordinator as well as the SBN Global Coordinator. The Summit presented opportunities for engagement with country delegates, constituents from various SUN networks, as well as international partners and donors.

A total of 106 countries participated in the Summit. Out of the 76 delegations representing low- and middle-income countries accredited to attend, 61 delegations (80%) belonged to the SUN Movement. Among these, 33 SUN Focal Points were active participants, contributing to a wide range of sessions and side events throughout the Summit. In addition, all SUN Donor Network members actively participated in the Summit.

The SUN Movement had a presence across official Summit sessions. 100% of the plenary sessions featured at least one speaker representing a SUN country. Delegates from 20 distinct SUN Country governments assumed speaking roles during the opening ceremony, plenary sessions, round tables, and the closing ceremony of the Summit. Côte d'Ivoire, a contributor to the event as co-chair of the International Advisory Group (IAG), participated in the opening ceremony and two plenary sessions. Additionally, representatives from three other SUN countries made interventions from the floor during plenary sessions.

The SUN Movement Coordinator moderated the financing plenary session and delivered closing remarks at the conclusion of the Summit. Furthermore, five members of the SUN Lead Group made contributions, serving either as keynote speakers or as moderators in various plenary sessions.

The SUN Civil Society Network (CSN) was also represented during the main conference proceedings. Nana Oleko, the Youth Coordinator from the Democratic Republic of Congo, delivered an address during the opening ceremony. In her speech, she shared personal

experiences of displacement due to conflict and urged global leaders to prioritize the nutritional needs of vulnerable populations, particularly those residing in fragile and conflict-affected contexts.

At the high-level closing ceremony of the Summit, SUN CSN Youth Coordinators collectively presented a jointly developed <u>Youth Declaration</u>. Finian Ali, the Youth Coordinator from Nigeria, was among those who delivered this message. The declaration's call to action was grounded in testimonies gathered from children and young people who had participated in the global Nutrition Dialogues, reflecting their voices and priorities. Also during the closing ceremony, the Head of SUN CSN delivered a speech on behalf of the civil society constituency. This speech was based on the <u>Civil Society Declaration</u>, a document coordinated by the SUN CSN and endorsed by over 150 organizations, which called upon leaders to fund, empower, and listen to individuals and communities closest to nutrition challenges.

Participation in Side Events - Beyond the formal proceedings of the main conference, the SUN Movement co-organised or engaged in numerous side events organized throughout the N4G week. All networks were represented. The SUN Movement Coordinator spoke at six different side events, supplementing her commitments within the official main agenda. Details regarding engagement in the side events related to the Nutrition Integration Compact and Coalition are described in Section VIII. At the CSO Pavilion, in addition to the activities undertaken by the SUN CSN (detailed in Section IX), the SUN Movement Secretariat team contributed personnel as speakers and moderators to events focused on financing and accountability. These events were co-organized with partners including the SDG2 Advocacy Hub, 4SD, World Vision, and the CSN. The SUN Movement Coordinator also provided closing remarks for the first day of the CSO Pavilion. Furthermore, at the Scientific Conference, organized by the Agence Française de Développement on March 26, 2025, government representatives and academics hailing from eight different SUN countries made contributions as speakers, sharing their expertise and research findings. Members of the SUN Donor Networks were involved in the organization of nine side-events covering a variety of topics such as intersections of climate action and nutrition, agroecology, the role of nutrition in combating tuberculosis, measuring dietary quality, sustaining nutrition in crises, and shaping sustainable food systems for a healthier planet.

VII. Outcomes of the N4G Paris Summit

Despite operating within a challenging global financial environment, the pledges announced at the N4G Summit by actors—including donors, development banks, philanthropic organizations, businesses, and partners—reached a total amount approaching USD 28 billion (with USD 27.55 billion officially reported). This figure represents an increase in commitments compared to the N4G 2021 Tokyo Summit.

The 2025 Nutrition for Growth Summit host recognized the work and contribution of the International Advisory Group (IAG), co-chaired by Côte d'Ivoire and the SUN Movement, along with its various thematic working groups, in the preparation of the Summit.

<u>The final declaration of the Summit</u> underscored continuity and accountability, stating that a coalition of partners, working in conjunction with the SUN Movement, will ensure coherence and sustained momentum between N4G Summits. This collaboration will focus on operationalizing the commitments made, utilizing the Nutrition Accountability Framework (NAF) as the principal tool for the accountability process.

<u>The declaration of the Summit Annex</u> provides a succinct analysis of the commitments made by the different stakeholders and includes a comprehensive list of all commitments registered. 127 commitment makers spanning 66 countries registered 403 new commitments as of March 25, 2025. 55 non-donor governments made commitments during the event, with 48 of these (87%) being members of the SUN Movement. All financial commitments originating from non-donor national governments came exclusively from members of the SUN Movement. 66% of the commitments from SUN countries are related to the integration of nutrition in other sectors.
